

RE: Brookview Lane - Dedication of Roadway

The Attorneys for Brookview Lane Subdivision have submitted dedication papers (copies attached) to the Town of Harrison regarding the above-referenced roadway. The Town Engineer has inspected the roadway, found it acceptable for dedication and has set an amount of \$200,000.00 for a two-year (2) Maintenance Bond.

I hereby request that the Town Board pass a resolution authorizing the acceptance of this roadway dedication, subject to addressing all issues raised by the Building Department, Commissioner of Public Works and Town Engineer. Further, I hereby request that the Town Board be authorized to sign the Consent and the Supervisor and Commissioner of Public Works to sign any necessary documents to effectuate the closing.




The undersigned hereby applies to you to lay out a certain highway in the Town of


